#### EOIS-APPR:

- September 17, 2018: New participants for the 2018-19 school year may be entered on or after September 17, 2018. Please do not enter them before this date.
- October 19, 2018: All OYAP participants with active registered training agreements (RTAs) who have left high school prior to August 31, 2018 must be completed or withdrawn. Please begin this work after September 17, 2018.
- January 18, 2019: All OYAP participants (without RTAs) who have left high school prior to August 31, 2018 must be completed or withdrawn. Please begin this work after September 17, 2018.
  - Please note that the date entered for completed/withdrawn must be either the date the student graduated or left high school. Do not use the date that the data entry was done.
- January 18, 2019: All 2018-19 semester one OYAP participants must be entered.
- June 21, 2019: All 2018-19 semester two OYAP participants must be entered.
- September 13, 2019: All 2018-19 summer school OYAP participants must be entered.

- October 20, 2017: All OYAP participants with active registered training agreements (RTAs) who have left high school prior to August 31, 2017 must be completed or withdrawn. Please begin this work after September 15, 2017.
- January 19, 2018: All OYAP participants (without RTAs) who have left high school prior to August 31, 2017 must be completed or withdrawn. Please begin this work after September 15, 2017.
  - Please note that the date entered for completed/withdrawn must be either the date the student graduated or left high school. Do not use the date that the data entry was done.
- January 19, 2018: All 2017-18 semester one OYAP participants must be entered.
- June 22, 2018: All 2017-18 semester two OYAP participants must be entered.
- September 14, 2018: All 2017-18 summer school OYAP participants must be entered.
