**RE: Registration status of 1241060 Ontario Ltd. o/a Academy of Learning Career and Business College**

**Immediate Suspension under section 20 of the *Private Career Colleges Act, 2005***

The Ministry received your correspondence dated May 12, 2008, in which you indicate that the campus is planning to relocate to a new location. As of June 1, the PCC will have no current operating location.

Pursuant to section 20 of the *Private Career Colleges Act, 2005*, I hereby give notice that 1241060 Ontario Ltd. o/a Academy of Learning Career and Business College registration is suspended, **effective immediately/as of June 1, 2008.**

As a result of my decision,

1. Effective immediately, 1241060 Ontario Ltd. o/a Academy of Learning Career and Business College may no longer continue to enrol students in courses approved under the Act.
2. Effective immediately, 1241060 Ontario Ltd. o/a Academy of Learning Career and Business College is prohibited from advertising in any media that it is offering programs that required to be approved under the Act.

In your correspondence you indicated that at the appropriate time, a new business location will be secured. If the new location is approved, this would allow the Superintendent to lift the suspension. Therefore, please ensure that once you have a new location, the Ministry is provided with written confirmation of the new campus location by way of a Notification of Change Form and required documentations. **1241060 Ontario Ltd. o/a Academy of Learning Career and Business College**, has the right to appeal this suspension and proposed revocation. Information on the appeal process is set out in Schedule "A", attached to this letter.

## Schedule "A"

### **Entitlement to Hearing by Licence Appeal Tribunal:**

**1241060 Ontario Ltd. o/a Academy of Learning Career and Business College**, disagrees with the Superintendent's decision, it is entitled to a hearing by the Licence Appeal Tribunal ("Tribunal") if it mails or delivers to both the Superintendent of Private Career Colleges and the Tribunal, a notice in writing requesting such a hearing.

Such notice must be delivered, **by registered mail or courier**, to the Superintendent and to the Tribunal by **June 15, 2008**.

If **1241060 Ontario Ltd. o/a Academy of Learning Career and Business College** does not require a hearing by the Tribunal as set out above, the decision to suspend the registration will continue until the registration is revoked or until **1241060 Ontario Ltd. o/a Academy of Learning Career and Business College** registration lapses. If **1241060 Ontario Ltd. o/a Academy of Learning Career and Business College** does not request a hearing by **June 2008** the Superintendent will immediately thereafter carry out the proposal to revoke **1241060 Ontario Ltd. o/a Academy of Learning Career and Business College**, registration.

**In the case of a provisional/immediate suspension issued under section 20 of the Act, a request for a hearing by 1241060 Ontario Ltd. o/a Academy of Learning Career and Business College does not stay the suspension: the suspension continues, unless otherwise directed by the Tribunal.**
