

# **Better Jobs Ontario Eligibility and Suitability Assessment Template**

Key changes include:

- Updating "Type of Skills Training" and "Occupational Experience" criterion to reflect Guideline changes,
- Added a new checkbox to the bottom of the template for service providers to specify if the applicant "Does not meet the suitability baseline score but is being recommended as an exception."

The Better Jobs Ontario Eligibility and Suitability Assessment Template is located within the Assessments tab on the Employment Ontario Case Home page.

### **Next Steps:**

Effective today, service providers and applicants are advised to use the updated Better Jobs Ontario operational forms and tools, as provided on the EOPG. The Ministry has established a one-month grace period until July 20<sup>th</sup>, 2023, for applicants who were in the process of completing applications prior to the NOC 2021 launch. During the grace period, applicants that were in the process of completing their applications will not be required to resubmit their applications using updated forms.
